Introduction

The primary objective of internal audit is to review, appraise and report upon the adequacy of internal control systems operating throughout the council. To achieve this SALC adopt a predominantly systems-based approach to audit.

The council's internal control system comprises the whole network of systems established within the council to provide reasonable assurance that the council's objectives will be achieved, with reference to:

- the effectiveness of operations
- the economic and efficient use of resources
- compliance with applicable policies, procedures, laws, and regulations
- the safeguarding of assets and interests from losses of all kinds, including those arising from fraud, irregularity, and corruption



• the integrity and reliability of information, accounts, and data

Methodology

When conducting the audit, the internal auditor may:

- conduct a selective assessment of compliance with relevant procedures and controls expected to be in operation during the financial year in order to be able to complete the Annual Internal Audit Report 2023/24 of the Annual Governance and Accountability Return (AGAR)
- review the reliability and integrity of financial information and the means used to identify, measure, classify and report such information
- review the means of safeguarding assets and, as appropriate, verify the existence of such assets
- appraise the economy and efficiency with which resources are employed, identify opportunities to improve performance and recommend solutions to problems
- review the established systems to ensure compliance with those policies, procedures, laws, and regulations which could have a significant impact on operations, and determine whether the council complies
- review the operations and activities to ascertain whether results are consistent with objectives and whether they are being conducted as planned



Section 1 - proper bookkeeping

The internal auditor will look at the methods and processes used to manage the council's accounts and in particular that it provides clear data for reporting and monitoring purposes. This includes checking information is accurate, kept up to date, referenced and verified.

YES	The council uses an excel spreadsheet to form the basis of its accounts and ensures that the financial transactions of the parish council are as accurate as reasonably practicable. All transactions are well referenced and provide an effective tool for the basis of the council's internal controls.		
Is the ledger on the correct basis in relation to the gross income/expenditure? (under Proper Practices, Councils are required to work on an Income & Expenditure basis when their gross income, or gross expenditure, exceeds £200,000 for 3 consecutive years)	YES	Councils accounts are conducted on a payments and receipts basis.		
Is the cash book up to date and regularly verified?	YES	Council follows Proper Practices in ensuring that its accounting procedure gives an accurate presentation of the true financial position. The Responsible Financial Officer produces clear financial management information to the council on both a monthly and annual basis.		
Is the arithmetic correct?	YES	A number of spot checks were carried out and the functionality of the cashbook was found to be in order.

YES	The Standing Orders, as seen on the Parish Council's website, show an adopted date of 7 th September 2023 with a second review date noted in the minutes of the meeting held 5 th October 2023. The Standing Orders, are based on the latest model published by the National Association of Local Councils (2018) and contain the provisions of the Model Councillor Code of Conduct as adopted by council on the 11 th May 2023. The Standing Orders are compliant with legislation and have been adapted (where they are not statutory requirements) to ensure that they are relevant to the Parish Council.
Are Financial Regulations up to date and reviewed annually?	YES	Financial Regulations, as seen on the Council's website show a review date of 7th March 2024 and are based on the NALC Model Financial Regulations 2019. COMMENT: Council should note that revised Financial Regulations are being published by NALC and that these should be considered within its next review.
Has the Council properly tailored the Financial Regulations?	YES	The Council's Financial Regulations have been tailored to the Parish Council.
Has the Council appointed a Responsible Financial Officer (RFO)? ¹	YES	In accordance with Section 151 of the Local Government Act 1972(d) (financial administration), the Council has appointed a person (the Clerk) to be responsible for the administration of the financial affairs of the relevant authority as per Financial Regulations 1.8.

Section 3 – Payment controls

The internal auditor will specifically check bank reconciliation including credit/debit cards and management approval processes and evidence that internal Financial Regulations (FO) are being followed. The internal auditor will examine how regular payments are managed and specifically seek evidence that these have been brought back to the Council for verification purposes especially where the actual payment made differs from the amount previously agreed. VAT should be clearly identified including evidence that claims have been correctly managed. The internal auditor will check if the Council has a clear understanding on eligibility in relation to the General Power of Competence and that s.137 has been correctly applied and managed.

Is there supporting paperwork for payments with appropriate authorisation?	YES	A selection of random payments were cross checked against the cash book, bank statement and invoices, and all were found to be recorded and authorised in accordance with Proper Practices. Payments are detailed within the council minutes alongside the powers used to authorise such payments.
Where applicable, are internet banking transactions properly recorded and approved?	YES	Internet banking is operated in accordance with the Council's own Financial Regulations and is used for the settlement of the Council's expenditure. Evidence was provided of the Unity Trust Bank detailing the Clerk / RFO submitting the payments and a councillor requirement for authorisation.
Is VAT correctly identified, recorded, and claimed within time limits?	YES	VAT is clearly identified within the cashbook and notes one receipt during the period under review of £3,324.86 covering 29 th January 2023 to 31 st December 2023. For 2023-2024 a total amount of VAT recorded is £960.42.
Has the Council adopted the General Power of Competence (GPOC) and is there evidence this is being applied correctly? ²	N/A	Council has not adopted the General Power of Competence.

YES	The Financial Risk Assessment documentation as reviewed provides details of the risks associated with the functioning of a smaller authority and the measures that the Council will undertake to mitigate such risks. The Risk Register for the year under review was considered and adopted by full Council at its meeting of 7 th December 2023.
Is there evidence that risks are being identified and managed?	YES	Council is aware that risk assessment needs to focus on the safety of the parish council's assets and in particular its money. There is evidence that the parish council has taken action to identify and assess those risks and has considered what actions or decisions it needs to take during the year to manage in order to avoid financial or reputational consequences.

YES	Council has insurance in place under a specialist policy for local councils with Ansvar Insurance which shows core cover for the following: Public/Products Liability £10m; Employers Liability £10m and Fidelity Guarantee of £250k. The insurance was reviewed and approved by council at a meeting held 7 th September 2023. The period of insurance covers 1 st October 2023 to 30 th September 2024.
Evidence that internal controls are documented and regularly reviewed ⁴	YES	At the meeting of 7 th March 2024 Council, in accordance with Regulation 6 of the Accounts and Audit Regulations 2015, confirmed that the financial and management systems of the council were sound and adequate and internal control arrangements were efficient and effective to address the risks associated with the management of public finances.
Evidence that a review of the effectiveness of internal audit was conducted during the year, including consideration of the independence and competence of the internal auditor prior to their appointment ⁵	YES	In accordance with the Accounts and Audit Regulations 2015, the Parish Council formally reviewed the scope and effectiveness of its internal audit arrangements, evidence of which is contained within its Internal Control Policy as adopted on 7 TH March 2024.

COMMENT: To ensure transparency in the budgetary process council might wish to evidence by recording within the minutes, the budget being set.
Verify that the precept amount has been agreed in full Council and clearly minuted	YES	The precept was set at £14,701.67 for 2023/2024, as confirmed at the above meeting, with the paperwork demonstrating that this was a 0% change over that set the previous year.
Regular reporting of expenditure and variances from budget	YES	The minutes evidence that Council carried out quarterly reviews covering the budget with a review of income and expenditure against budget. This was recorded in its minutes of meetings held 11 th May 2023, 2 nd November 2023, 11 th January 2024 and 7 th March 2024.
Reserves held – general and earmarked ⁶	YES	The Council, as at year-end, had Earmarked Reserves totalling £41,997.75 with the balance being General Reserves of £18,306.47.

Does the precept recorded agree to the Council Tax Authority's notification?	YES	Council received precept in the sum of £14,701.67 from East Suffolk Council for the period under review as reported to full Council within its minutes of the meetings held 11 th May 2023 and 2 nd November 2023. Evidence was provided showing a full audit trail from Precept being discussed and approved to being served on the Charging Authority to remittance advice showing the Precept to be paid and receipt of same in the Council's Bank Account.

Employment contracts were not reviewed during the internal audit but the Clerk to the Council has confirmed that a Contract of Employment is in place. All salary payments are presented to the Council for approval and payments made in accordance with Council's own Financial Regulations.
That the Council approved dataly para.	720	An increase in hours and salary was approved by council at a meeting held 6 th July 2023. No employee is paid the national minimum wage.

Are arrangements in place for authorising of the payroll and payments to the council? Does this include a verification process for agreeing rates of pay to be applied?	YES	There are suitable payroll arrangements in place which ensures the accuracy and legitimacy of payments of salaries and wages, and associated liabilities and as such the council has complied with its duties under legislation.
Do salary payments include deductions for PAYE/NIC? Is PAYE/NIC paid promptly to HMRC?	YES	The payroll function for the year under review is operated in accordance with HM Revenue and Customs guidelines. Cross-checks were completed on three payments covering salary and PAYE were found to be in order. Deductions paid to HM Revenue and Customs during the year under review were made in accordance with timescales as set out in the regulations.

A clear audit trail should be available when items are purchased including minutes to evidence approval.

Does the Council maintain a register of material assets it owns and manage this in accordance with proper practices? ⁹	YES	The Asset Register, as viewed on the Council's website, and as approved at the meeting of 7 th March 2024 reflects those items listed under insurance and within the Parish Council's remit for maintenance and ownership. It is noted that the declared value for all assets at year-end is £101,160.65 which reflects overall movement in the asset register covering acquisitions and disposals.

Do bank balances agree with bank statements?	YES	Bank balances agree with period end statements and, as at year end 31 st March 2024 the balance across the council's accounts stood at £60,473.05. COMMENT: The end of year accounts records a total balance of £60,304.22 which requires amending noting the figure for the Unity Trust Bank Fixed Deposit 1 which has an actual end balance of £7,611.05 (not £7,442.22) to include the interest received. RECOMMENDATION: The draft AGAR should be amended to reflect these corrected figures with an end balance of £60,473.05 in accordance with the bank statements and bank reconciliation.
Is there regular reporting of bank balances at Council meetings?	YES	Balances across the Council's accounts are reported at each meeting of full Council within its financial report.
